REPRESENTATIVE EXPERIENCE

Won summary judgment and final dismissal of a case in the Western District of Virginia against a nurse practitioner and nurse where allegations involved failure to properly treat MRSA

Won summary judgment and final dismissal of a case in Henrico, Virginia against a primary care physician where allegations involved failure to interpret EKG results and failure to diagnose impending myocardial infarction

Dismissal of a complaint against a licensed practical nurse following a formal hearing with the Board of Nursing. Allegations involved failure to respond to and report two patient falls at a rehabilitation center.

Forced non-suit in Chesapeake, Virginia in a case against two family physicians involving allegations of failure to identify abnormal EKG results and failure to diagnose acute cardiac condition

Dismissal of a case against a pediatric intensivist in Norfolk where allegations involved failure to diagnose worsening pulmonary status, failure to properly supervise resident physicians, and failure to diagnose misplacement of enteric tube

Defense verdict in Newport News, Virginia for a general surgeon where plaintiff alleged the surgeon caused enterotomies during hernia surgery and failed to return the patient to the operating room for exploration and removal of ischemic portions of bowel

Won summary judgment and final dismissal of a case against a nurse practitioner in Abingdon where plaintiff alleged negligence and deliberate indifference during treatment of Hepatitis C

Dismissal of a case against a hospitalist and nurse practitioner in Petersburg where allegations involved failure to diagnose liver failure and failure to transfer to a liver transplant center

Won summary judgment and final dismissal of a case against a physician in Lynchburg where plaintiff alleged negligence and deliberate indifference during treatment of a broken bone

Successfully petitioned court in Norfolk, Virginia on behalf of pediatric geneticist to order life-saving stem cell transplant for infant patient with Hurler Syndrome

Won summary judgment and final dismissal of a case against several correctional health care providers where plaintiff alleged

negligence and deliberate indifference during treatment of diabetes, hypertension, and periodontitis

Defense verdict in Salem, Virginia for hospital nurses where plaintiff with myoclonus alleged that a breach of the nursing standard of care caused him to spill hot coffee and injure himself

Won a motion to set aside the verdict in Norfolk Circuit Court by arguing that the jury incorrectly ignored contributory negligence by the plaintiff

Dismissal of a complaint against a physical therapist assistant following an informal hearing with the Board of Physical Therapy. Allegations involved improper documentation of physical therapy assessments.

Defense verdict in Richmond, Virginia for a general surgeon in a case involving allegations of misdiagnosed infection following surgical correction of diverticula and a fistula track between the cecum and bladder
